



## PRIZE COMPETITION TERMS AND CONDITIONS

1. The Promoter is VICE Benelux B.V., whose registered office is at Reguliersdwarstraat 90-92, 1017 BN te Amsterdam (“**VICE**”).
2. The title of the competition is **Golden Ticket**
3. The competition will run from June 14th 2018 (**the “Opening Date”**) to July 1st 2018 23:59 (**the “Closing Date”**).
4. All competition entries must be received by the Promoter by no later than 23:59 on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
5. To enter the competition:

7. The promoter will not accept:
  - a. responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
  - b. proof of transmission as proof of receipt of entry to the competition.
8. Entrants to this competition and the winners of any prizes are subject to these terms and conditions. By submitting your entry, you agree to comply with these terms and conditions.

13. In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. The Promoter may require you to provide proof that you are eligible to enter the competition.
14. The Promoter will not accept competition entries that are:
  - incomplete; and/or
  - false.

16. The Promoter reserves the rights to disqualify you if your conduct is contrary to the spirit or intention of the competition.

24. The decision of VICE is final and no correspondence or discussion will be entered into.

If the winner cannot be contacted or is not available, or has not claimed their prize within 7 days of the Announcement Date, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.
26. The Promoter does not accept any responsibility if you are not able to take up the prize.
27. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

29. If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude you from participating in the competition.
30. The Promoter reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.
31. These terms and conditions shall be governed by the laws of the Netherlands, and the parties submit to the non-exclusive jurisdiction of the courts of Amsterdam.
